

#### **Port Visa Application Instructions**

#### What is the process?

### \* Before you arrive at the Shanghai airport:

- 1. Please fill in the "Port Visa Application Form" online <a href="https://jinshuju.net/f/YzBgjA">https://jinshuju.net/f/YzBgjA</a> and submit all documents accurately **before June 7**th.
- 2. Your information will be submitted to and reviewed by Shanghai Entry-Exit Administration within 5 working days if all information and document are accurate.
- 3. Once your application is approved, **Port Visa Acceptance Form** will be issued and sent to you via email for your application when you arrive Shanghai Airport.

#### \* When you arrive at the Shanghai airport:

- 1. You can apply for Post Visa when you arrive Shanghai airport with the **Port Visa Acceptance Form**, your original passport, one printed personal photo (In color, 3.5(w)\*5.3(h) centimeters in size, bare-headed, full face, bust photograph taken within 6 months)
- 2. You shall pay the visa application fee in RMB cash ONLY according to the regulations when applying for a port visa at Shanghai airport. Please make sure you have enough RMB cash with you before you arrive Shanghai airport.
- 3. Shanghai port visa office shall issue a single-entry visa with maximum stay duration of 30 days to qualified foreign applicants after verification and approval.



#### Note:

- 1. Port visa is also known as visa on arrival (VOA), a port visa allows foreigners to enter China without having to obtain a visa at the Chinese embassy before their departure.
- 2. If you need to enter China for urgent matters, or it is too late to apply for a business visa at the Chinese embassy or visa application centre, you may apply for a port visa before and after arriving at Shanghai.
- 3. CPHI & PMEC China team can help you get a port visa to Shanghai. The number of days allowed for the port visa to Shanghai is maximum 30 days. However, it is not guaranteed that a port visa to Shanghai will be issued to everyone. It is advisable to get a visa before departure.
- **4.** The organisers of CPHI & PMEC China have registered at the Exit-Entry Administration of Shanghai Public Security Bureau and have been authorised the right to help qualified exhibitors and visitors to apply for port visa to Shanghai.
- 5. Passport holders of most countries can easily get a VOA except for Afghanistan, Iran, Iraq, Pakistan, Sri Lanka, Yemen, Nigeria.
- 6. If you change or cancel your trip or flight or hotels after getting Port Visa

  Acceptance Form, kindly let us know as soon as possible.
